

## 2. MEMBERSHIP OF THE MEDICAL COUNCIL AND THE GENERAL ELECTION HELD IN 2006



2.1 The Council comprises 24 medical practitioners and 4 lay members. The Director of Health is the ex-officio Registrar. The composition of the Council is as follows:-
